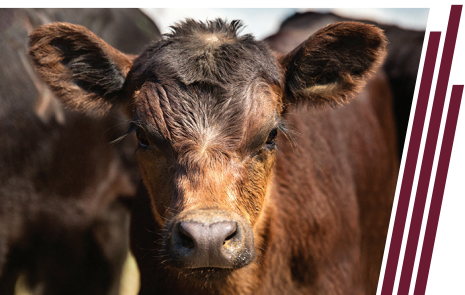
### LIVESTOCK AUDITS
